Most signed in as Western Star, but we got larger share of the money because we had two supervisors. [Sign docs to be eligible for Beer Booth next time. [Total (643.00) in September. [We can't afford to have Angel's not pay. Should have "can't pay" option. [Steve proposes Angel's pay X ("Angel Tax") = \$40 / 8 wks, people enrolled in class \$50 / 8 wks.

Merger Plan	<ul style="list-style-type: none"> [Delegates selected on both sides. [Have yet to meet. [Bob Brundage and Rick Collins representatives from Western Star. Dan and Steve from Foggy City. [\$2,500 to 501c3 status; advice free. Same lawyer who did Foggy City's original paperwork. As long as our goals are the same, he doesn't see a problem. [Entire membership will have to vote, with majority rules.

[Working with Western Star regarding decorations for next dance Party Decorations, Leather and Lace, 28th September 2013. [They're getting cake; we're dealing with caller. [Staying with Donald and Eloise. [Upgrade Classes through the end of the year. [Some people are advocating for an Advanced Class. Next class starting in January 2014 should be full Advanced. Two intro nights starting 6th January 2014. Unanimously approved.
